As the products you are purchasing, leasing or receiving from LJS Aviation Ltd may be exported or re-exported and used outside the US, UK or EU please confirm the following:

- 1) I (we) will not sell, transfer, export or re-export any products supplied by LJS Aviation to any restricted/sanctioned country of the US, UK or EU such as **Cuba, Iran, North Korea, Syria, Sudan, Russia, the Crimea region of Ukraine or any parts of the Donetsk oblast and the Luhansk oblast of Ukraine as determined in Decree Number 32/2019 issued by the President of Ukraine on 7th February 2019**; unless otherwise authorised by EU, UK or US authorities. It is the responsibility of your company to monitor these restrictions and sanctions lists.
- 2) I (we) will not sell, transfer, export or re-export any products supplied by LJS Aviation for use in activities which involve the development, production, use or stockpiling of nuclear, chemical, biological weapons or missiles, or other weapons of mass destruction, nor use products in any facilities which engage in activities relating to such weapons.
- 3) I (we) will not sell, transfer, export or re-export any Products to persons (individuals or entities) that are prohibited by applicable US export control laws and regulations, including persons named on the US Commerce Department's Denied Persons List, Entity List, Unverified List, the US Treasury Department's List of Specially Designed Nationals and Blocked Persons (SDNs) and the US Department of State's Debarred List and other lists associated with its implementation of nonproliferation sanctions. I (we) also acknowledge that EU/UK law prohibits sale, transfer, export or re-export or other participation in any transaction involving products with individuals or companies listed on the EU Consolidated List, EU Arms Embargoes List or any other entity lists published by the EU or UK authorities.
- 4) I (we) will abide by all compliance requirements applicable to the Products under US, UK, EU export control laws and regulations, including but not limited to the Export Administration Regulations (EAR), International Traffic in Arms Regulations (ITAR), and will obtain any required authorisation from the US, UK, EU authorities/government for the subsequent use, resale, export, transfer or re-export of such Products. LJS Aviation Ltd reserves the right to obtain proof of such authorisation as a condition to making any sale or transfer of such Products to you.
- 5) Should I (we) become aware of any possible violation of applicable US/UK/EU export control laws or regulations with respect to the Products or of any breach of this certification, I (We) will immediately notify LJS Aviation Ltd of the facts and circumstances and will fully cooperate with any investigation and prompt resolution of same.
- 6) I (we) agree that the export control requirements in 1-5 shall survive the completion, early termination, cancellation, or expiration of any applicable order, agreement or contract with LJS Aviation Ltd. Completion of this agreement applies to the company listed below and includes all subsidiaries and affiliated companies.
